

Newberry Community Services District





- Included in this section is a cumulative general ledger as of April 30, 2012.
- Included in this section is a brief general overview of past reserve funds commonly referred to as the "Kiewit Funds" to show the funds have been expended over the past years.
- The Fire Dept and I had one preliminary budget meeting and we will be holding a second budget strategy meeting on May 9, 2012.
- For the Board's consideration on this meeting's agenda is a request to purchase new accounting software.
- Efforts continue to dispose of surplus equipment and there is a business item for an informational update on the status of surplus disposal.
- Work continues on the annex building. There is a metal handicap ramp at station 392 currently used for hose drying. This ramp should be suitable for a ramp at the annex building with some minor modification. Moving of the ramp will be coordinated with the Fire Chief. A replacement hose drying rack would need to be purchased for the fire station.
- The Martial Arts Class on April 24, 2012 presented the District with a "Thank You" plaque for allowing them to use the community center for classes along with a check for \$300.00 raised through kick-a-thons. Classes have been suspended for now until an instructor is available for regular weekly classes in Newberry Springs.
- The District has been offered a donation of improved sound system equipment along with the installation of the equipment for the community center.
- July 3rd event Update:
 - Fireworks have been ordered and the 50% deposit has been paid
 - A band has been secured to provide live music for the event. We will once again be using the Main Stream Band.
 - A request has been made to the Newberry Springs Fire Department for them to provide an Honor Guard for the event
 - Formal letters of invitation to participate in the event have been sent to the Daggett CSD/Fire Department and the Yermo CSD/Fire Department
- Due to a personal commitment, I will be out of state July 4th through the 10th 2012.
 Efforts will be made to provide some staffing for the office while I am away, but the office will most likely have curtailed hours open to the public during that time period. I will be available to assist with operations via phone, text and e-mail.
